

The notation '[NP]' in a rule of the sailing instructions (SIs) means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

- 1 RULES
- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing*.
- 2 CHANGES TO SAILING INSTRUCTIONS
- 2.1 Any change to the sailing instructions will be posted before 0900 on the day it will take effect, except that any change to the schedule of races will be posted by 2000 on the day before it will take effect.
- 2.2 Changes to a sailing instruction may be made on the water by ON station Race Committee via VHF radio.
- 3 COMMUNICATIONS WITH COMPETITORS
- 3.1 Notices to competitors will be posted on the official notice board located in the main hallway in the DYC clubhouse.
- 3.2 On the water, the race committee intends to monitor and communicate with competitors on VHF radio channel 71.
- 4 CODE OF CONDUCT
- 4.1 [DP] Competitors and support persons shall comply with reasonable requests from race officials.
- 4.2 [DP] Competitors and support persons shall handle any equipment by the organizing authority with care, seamanship, in accordance with any instructions for its use and without interfering with its functionality.

- 5 SIGNALS MADE ASHORE
- 5.1 Signals made ashore will be displayed at DYC flagpole.
- 5.2 When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 30 minutes' in Race Signals AP.
- 5.3 [DP] Flag D with one sound means 'Boats are requested to not leave the harbour until this signal is made. The warning signal will not be made before the scheduled time or less than 15 minutes after flag D is displayed.'
- 6 SCHEDULE OF RACES
- 6.1 The race will take place on Sunday, October 6<sup>th</sup>, 2024.
- 6.2 The first warning signal may not be made prior to 13:00.
- 7 RACING AREA
- 7.1 The racing area is on WestNorthWest of the canal entrance to DYC.
- 8 COURSES
- 8.1 The course will be from start line to Frostbite Virtual Mark (to Port) to finish line.
- 8.2 The course is approximately ~6 nautical miles.
- 9 MARKS
- 9.1 Marks

DYC Mark C	N 43.13.250 W 79 17.330
Frostbite Virtual Mark	N 43 16.285 W 79 17.294

- 10 THE START
- 10.1 The starting line will be between the Orange Flag on the RC Vessel and Mark C.
- 10.2 The RC can start any single or combination of fleets they see fit.
- 10.3 Fleet pennant flags will be:

Kirby 25: Numerical Pennant 1 PHRF SPIN: Numerical Pennant 2 Main and Jib: Numerical Pennant 4

- 10.4 A boat that does not start within 15 minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A5.1 and A5.2.
- 11 THE FINISH
- 11.1 Between a Blue Flag which is mid-ship on the RC Vessel and Mark C.

- 11.2 If the race committee is absent when a boat finishes, she shall report her finishing time, and her position in relation to nearby boats, to the race committee at the first reasonable opportunity.
- 11.3 Record the following data and email racing@dalhousieyachtclub.com;
  - Boat name and sail number
  - Skippers name
  - Whether you sailed FS or NFS
  - Your GPS finish time
  - Boat ahead and boat behind if possible
- 12 TIME LIMITS
- 12.1 The Virtual Mark Time Limit and the Race Time Limit (see RRS 35).

Virtual Mark	Race Time
Time Limit	Limit
15:00	16:30

- 12.2 If no boat has passed the first mark within the Virtual Mark Time Limit, the race will be abandoned.
- 13 HEARING REQUESTS
- 13.1 The protest time limit is 60 minutes after the last boat finishes the last race of the day.

- 13.3 Notices will be posted no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses.
- 13.4 RRS 62.2(a) and 66.2(a) do not apply.
- 14 SAFETY REGULATIONS
- 14.1 A boat will have all mandatory safety equipment per Transport Canada's Mandatory Safety Equipment, including a working VHF radio.
- 14.2 A boat that retires from a race shall notify via email racing@dalhousieyachtclub.com at the first reasonable opportunity.
- 15 EQUIPMENT AND MEASUREMENT CHECKS
- 15.1 A boat or equipment may be inspected at any time for compliance with the class rules, notice of race and sailing instructions.
- 16 TRASH DISPOSAL

- 16.1 Trash may be placed aboard official [or support person] vessels.
- 17 PRIZES
- 17.1 Prizes will be given for trophy for first place (trophy name TBD).
- 18 RISK STATEMENT
- 18.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury.

  Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.
- 19 INSURANCE
- 19.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$2,000,000 per incident or the equivalent.
